ELIGIBILITY FOR PARTICIPATION IN STUDENT LIFE ACTIVITIES

Dalton State College takes great pride in having students participate in collegiate activities of both non-competitive and competitive nature. For this reason, any student seeking to participate in such activities must comply with eligibility guidelines, including but not limited to:

1. Unless a student is a first-semester freshman, the student must be currently matriculating with at least three (3) credit hours. These are the minimum standards set by the Dean of Students Office. Each sponsoring group may set higher credit requirements.
2. Unless a student is a first-semester freshman, the student must currently have a cumulative GPA of at least 2.0. These are the minimum standards set by the Dean of Students Office. Each sponsoring group may set higher GPA requirements.
3. The student must be in good academic and conduct standing.
4. The student must be eligible based on guidelines of the organization sponsoring the activity.
5. Student Life will review students representing Dalton State College in such activities for eligibility to represent the College.
6. Participation in activities (non-competitive and competitive) is not guaranteed.

By signing below, I agree that, should I choose not to attend the activity, I will be responsible for repaying any related costs paid on my behalf by Dalton State College.

Dalton State College Policy on Alcohol, Drugs and Tobacco

ALCOHOL:

1. Use, possession, consumption, sale, manufacturing, or distribution of alcoholic beverages or paraphernalia (except as expressly permitted by College regulations), including public intoxication, on college premises. This is to include off campus distribution of alcoholic beverages by students to students under twenty-one (21) years of age.
2. Students, of legal drinking age, as designated by the state in which the activity is being held, are permitted to purchase, possess, and consume alcoholic beverages at off-campus activities that are not being funded through student activity funds, institutional funds, or the utilization of campus resources (i.e. State Vehicle). If alcohol is present, attendance must never be required. If an event is mandatory, no alcohol may be served. Even the perception of, or encouragement of, required attendance must always be avoided. Persons under the legal drinking age are strictly prohibited from purchasing, possessing, or consuming alcoholic beverages.

DRUGS:

1. The possession or use (without valid medical or dental prescription), manufacture, distribution, or sale of any federal or state controlled substances, even synthetic varieties (to include prescription drugs and/or any item misused for the purpose of intoxication).

TOBACCO:

University System of Georgia, Board of Regents Policy Manual, 9.1.7 Tobacco and Smoke-Free Campus Policy

In accordance with the Georgia Smoke Free Air Act of 2005, Title 31 Chapter 12A, this policy reinforces the USG commitment to provide a safe and amicable workplace for all employees. The goal of the policy is to preserve and improve the health, comfort and environment of students, employees and any persons occupying our campuses.

The use of all forms of tobacco products on property owned, leased, rented, in the possession of, or in any way used by the USG or its affiliates is expressly prohibited. "Tobacco Products" is defined as cigarettes, cigars, pipes, all forms of smokeless tobacco, clove cigarettes and any other smoking devices that use tobacco such as hookahs or simulate the use of tobacco such as electronic cigarettes.

Further, this policy prohibits any advertising, sale, or free sampling of tobacco products on USG properties unless specifically stated for research purposes. This prohibition includes but is not limited to all areas indoors and outdoors, buildings and parking lots owned, leased, rented or otherwise used by the USG or its affiliates. The use of tobacco products is prohibited in all vehicles – private or public vehicles - located on USG properties.

This policy applies to all persons who enter the areas described above, including but not limited to students, faculty, staff, contractors and subcontractors, spectators, and visitors. All events hosted by a USG entity shall be tobacco-free. All events hosted by outside groups on behalf of the USG shall also be tobacco-free.

DSC vehicles are considered an extension of campus, and tobacco use is prohibited inside them. If in violation, I understand that charges will be brought to the Student Conduct Board. Furthermore, I understand and agree with the Student Code of Conduct and the Conduct Information and Regulations found on-line in the DSC Student Handbook and on Student Conduct's website.

Students should be aware that they are responsible for abiding by the above policies and that they may be held liable, both civilly and criminally, in the case that they are found in violation. When students travel, they should know that their point of destination is considered an extension of the campus. Violations occurring off campus will be treated the same as if the violations occurred on campus.

RELEASE, WAIVER OF LIABILITY AND COVENANT NOT TO SUE

(Read carefully before signing)

Many recreational and/or student activities involve substantial risks of bodily injury, property, damage, and other dangers associated with participation in such activities. Dangers related to such activities include but are not limited to: hypothermia, broken bones, strains, sprains, bruises, drowning, concussion, heart attack, and heat exhaustion.

Each participant in such activities should realize that there are risks, hazards, and dangers inherent in such activities, and in training and preparation for and travel to and from such activities. It is the sole responsibility of each participant to participate only in those activities for which he/she has the prerequisite skills, qualifications, preparations, and training.

The undersigned acknowledge that Dalton State College does not warrant or guarantee in any respect the competency or mental or physical condition of any trip leader, vehicle driver, or individual participant in any athletic, recreational, or student activity.

All participants in recreational/student activities will be required to sign the release, waiver of liability, and covenant not to sue form below.

*I acknowledge that I am solely responsible for any hospital or other costs arising out of bodily injury or property damage sustained through my participation in such voluntary athletic or recreational activities. In this regard, I certify that I am covered by a 24-hour health and accident insurance policy, and if not, **I will be responsible for all medical and/or any other bills incurred.** I have received a copy of this notice, which I have read and understand. I accept and assume all risks, hazards, and dangers involved in any such activities in which I may elect to participate, including the training and preparation for and travel to and from the site of such activities.*

RELEASE, WAIVER OF LIABILITY AND COVENANT NOT TO SUE

The undersigned hereby acknowledge that participation in recreational and/or student activities involves inherent risks of physical injury, illness, or loss of personal property and assumes all such risks. The undersigned hereby agrees that for the consideration of Dalton State College allowing the undersigned to participate in athletic and any student activities and in connection therewith, making available to the undersigned for his/her use while participating in such programs or activities, certain equipment, facilities, ground, or personnel of the institution, the undersigned participant does hereby waive liability, release, and forever discharge the Institution and the Board of Regents of the University System of Georgia, its members individually, and its officers, agents, and employees of and from any and all claims, demands, rights, and causes of action of whatever kind or nature, arising out of all known and unknown, foreseen and unforeseen bodily and personal injuries, damage to property and the consequences thereof, including death, resulting from my voluntary participation in or in any way connected with such recreational programs, athletic activities, and/or student activities, events, and travel.

I further covenant and agree that for the consideration stated above I will not sue the Institution, the Board of Regents of the University System of Georgia, its members individually, its officers, agents, or employees for any claim for damages arising or growing out of my voluntary participation in recreational programs, athletic activities, and student activities, events and travel.

I understand that the acceptance of this release, waiver of liability, and covenant not to sue the Institution of the Board of Regents of Georgia or any agent or employees thereof, shall not constitute a waiver, in whole or in part, of sovereign or official immunity by said Board, its members, officers, agents, and employees.

I understand it is my responsibility to evaluate the condition of my health in relation to the demands of this activity. If uncertain, I will consult with a family physician. Further, I understand that Dalton State does not provide health insurance for participants and that I am responsible for obtaining adequate insurance for the eventuality that, if I drive any vehicle during the activity and/or travel to and from the activity, I will be personally responsible and liable for all damages and injuries arising there from, to the extent that said liability, damage, and/or injury is not covered by the Georgia State Tort Claims Act.

I agree to abide by all Dalton State College policies during my participation in this activity including the entire Student Code of Conduct and the Travel Policy.
