

**MEMORANDUM OF UNDERSTANDING**

The Center for International Education of Dalton State College (CIE) and the Sino-American International Strategic Research Society of the China Institute of Strategy & Management (SAISRS) Have reached the following agreement concerning hosting the Summer Study in China Program (SSCP), co-sponsored by Asia Council of the University System of Georgia (USG), in Chinese mainland.

**I. General Description of the Program**

*Group Size:* the estimated number of participant will be around 50, including program director(s), faculty members, and /or spouse or children of participating faculty members,

*Cities to Be Visited:* Beijing (place of entrance), Zhengzhou, Luoyang, Xi'an, and Shanghai (place of departure).

*Program Dates:* Early May and early June, or four weeks of duration.

*Transportation:* high-speed trains or tour buses within China.

*Lodging:* student dorms on Chinese university campuses or hotels certified to receive international travelers.

**II. The Responsibilities of SAISRS**

SAISRS will be responsible for making all the following travel-related arrangements inside China, with the exception of the lodging, transportation and activities at Zhengzhou University.

1. Coordinating hosting agencies or universities in the cities to be visited, selection of qualified travel service providers, monitoring the performance of these providers based on the program requirements.
2. Provide timely information to SSCP, help resolve changes or contingency with regard to program arrangement or special needs.

**III. The Responsibilities of CIE**

CIE and its co-sponsors will be responsible for program management.

1. Provide SAISRS with information pertaining to program itinerary, or possible cancellation of the program. Confirm program dates and supply the number of participants, participants' names, gender, date of birth, passport number, position and special needs in

accommodation.

2. Inform group members to obey the regulations and requests from hosting institutions and travel agencies, and make payment on agreed price quote and requirements.

#### IV. Other Items



1. During the time of the visit in China, it is individual participant's responsibility for their personal and safety, the safety of their properties.
2. CIE and SAISRS will determine the proper way to make the fund transfer. SAISRS will provide proof of receipt upon receiving the program payment.
3. This Memorandum is written in Chinese and translated in English versions. Both versions are identical in content, and shall be kept by each side.

#### V. Duration, Amendment, and Termination of this Memorandum

This Memorandum is expected to continue for two years from the date of signature by both sides, and may be extended. CIE and SAISRS may amend this Memorandum at any time. Either CIE or SAISRS may terminate this Memorandum for future cooperation with a written notification.
